Any images related to WAHS Baseball team trip to Myrtle Beach during the 2017-2018 school year, captured, stored or removed from any phone or electronic devices issued by the WBP or City of Williamsport or personal phone or electronic devices used for WBP business by any WBP officers, agents, detectives, or any other personnel, specifically from March 15, 2018 current date.

- 4. Call logs related to WAHS Baseball team trip to Myrtle Beach during the 2017-2018 school year from any phone or electronic devices issued by the WBP or City of Williamsport or personal phone or electronic devices used for WBP or City of Williamsport business used by any WBP officers, agents, detectives, or any other personnel, specifically from March 15, 2018 current date.
- 4. Per the content of the requests, the requester appears to be searching for records of the WBP related to a Williamsport Area High School baseball team trip to Myrtle beach, South Carolina, during 2017-2018.
- 5. I have inquired with relevant personnel and have concluded that no WBP officers were involved in any investigation or follow-up investigation of the incident referred to in the requests.
- 6. I have also inquired with relevant personnel as to whether any records exist in their possession as described in the request.
